Conditions of Entry



1. **All Lots must be at the Ag-Grow site by 8am on Thursday 26th June 2025. NO SALE DAY ARRIVALS ARE PERMITTED. Horses competing in the campdraft on Thursday 26th June must be on site before 3pm Wednesday 25th June.**
2. **All horses are to be inspected upon arrival and will not be able to complete pre workouts or the campdraft without inspection. Campdraft, Pre-Works and Inspection times will be determined after nominations close.**
3. **Sale entry fee of \$420 per lot (Inc GST) is due and payable with your pedigree entry form.** This fee will cover cataloguing, stock levy, advertising, and the marketing programme. A tax invoice will be forwarded to vendors upon finalisation of entries.
4. Elders does not guarantee that cattle will be available on the day of sale or for “pre work” purposes.
5. **GST.** Vendors must complete the GST declaration requirements on the entry form. This information will be used for GST disclosure of individual lots in the catalogue. The information provided to the selling agents regarding payment of proceeds cannot be changed once you have made the GST Declarations.
6. All pedigree nominations are to be signed and submitted by the vendor before the closing date, 31st March. Once entries have closed no substitute lots will be allowed. **No refunds will be paid on withdrawn lots.**
7. By signing the nomination form vendors agree to the sale entry conditions as set out by Elders Rural Services and abide by them.
8. All lots shall be ridden, prepared, and presented to a high sale standard.
9. All Lots are to be between the age of 2 to 15 years old.
10. **All lots must be for genuine sale.**
11. Elders Rural Services marketing fee of **8.5% + GST** (includes the Ag-Grow operator sale fee) will be charged on all lots sold and deducted from the vendor’s proceeds before settlement. Any lot passed in will be charged an offering fee of **3.5% + GST** on the passed in price.
12. Upon arrival at the sale venue, vendors will be required to present their lots for a pre-sale inspection (Time to be determined) and provide the following;
 - A) Biosecurity Horse Health Declaration - declare in writing to Elders Rural Services, any pre-existing condition apparent in their lot/s which under the terms and conditions of sale, require disclosure to the sale audience prior to the sale of that lot/s, ie. windsucking, etc.
 - B) Waybill - Vendors are required to have a fully completed waybill for horses travelling to the sale showing individual lot numbers, brands, description, etc. which must be handed in to an Elders Agent on arrival. No horses will be offered without a waybill being received.
 - C) As Registered and unregistered horses are eligible to enter the AG-Grow Elite Horse Sale;
 - C1) For all registered lots registration certificate is to be provided as well as signed transfer papers. Purchasers will be responsible for contacting the relevant breed societies.
 - C2) All unregistered horses need to be clearly identifiable with a brand.

Conditions of Entry

- C3) Horses cannot be catalogued as “Pending Registration”, if horses are pending registration they are to be catalogued as unregistered and then amendments will be made to all posts/information on the horse after the registration has been received and checked by Elders Rural Services.
- D) Insurance Waiver - Neither Elders nor AG-Grow Emerald accept any liability for any accident, damage, injury to horses, riders, beasts, ground, spectators, or any other person or property whatsoever.
13. Each vendor will be supplied with 2 event passes for entry to Ag-Grow (children are free). Other persons accompanying a vendor must pay the entry fee to enter the grounds.
 14. Vendors agree that any person undertaking the handling of their sale lots from the time of arrival at the Ag-Grow Field days site does so at their own risk whether they be a strapper, handler, trainer, rider and the like. An equestrian helmet approved by the Australian Standards Association or International equivalent, with chin strap securely fastened, **MUST** be worn by all riders under the age of 18 years, always, when riding horses at the Ag- Grow Field Days site. Under no circumstances is a rider under 18 years permitted to ride a stallion.
 15. Vendors agree to be bound by all decisions of the Elders Rural Services regarding conduct of the horse workouts, sale display and penning of sale lots, and the lotting of catalogue sale order. Vendors also agree that Elders Rural Services reserve the right to amend and edit any vendor notes supplied for lots as they determine, for printing in the catalogue.
 16. Comments listed in the catalogue relating to horses listed for sale are based on information supplied to Elders Rural Services by the vendors. If Elders Rural Services are unable to establish the accuracy or authenticity of such comments any purchaser should rely on their own enquiries in this regard.
 17. Restrictions on sale numbers may apply, vendors agree to abide by all decisions made by Elders Rural Services in determining lots for sale cataloguing. Refund of sale entry fee will be made for any horse/s not accepted for cataloguing.
 18. The Vendor agrees to give Elders Rural Services the sole right to sell any passed in lot at the nominated reserve price, for a period of 14 days after sale day.
 19. Vendors who breach the sale conditions of entry or whose actions are considered not in the best interests of the sale will not be invited to participate in future sales.

This Campdraft is not compulsory for sale horses, it is just an option if vendors wish to nominate their horses. Pre-works will be available on Thursday 26th June, for any horse that does not compete in the Campdraft on Thursday 26th June.

Campdraft Nominations are **NOT** included in your sale entry fee. Campdraft Nomination fees are \$80 per horse, and will be collected at a later date.

The Campdraft will have a prize pool of \$20,000 cash and prizes!

Vendors that enter their horses in the Campdraft and win a place will not receive their prize moneys until the horse has been sold through the sale ring on Friday 27th June, Unless a vet certificate can be provided from the vendor to Elders Rural Services. As per point 11 on Conditions of entry, any lot passed in will be charged an offering fee of 3.5% + GST on the passed in price.
